Chair Hohenstein called for Public Comment about any item not on the agenda.

Kenny Baker, Ireton Avenue, Homer, spoke regarding farm ground under water. He passed out pictures and plans. He stated the water along Hwy 35 takes a month to get to his property and a month to drain off. He cannot farm the property and wondered how he could pay taxes if he cannot raise a crop. He proposed draining to county ditch that would need to be dredged out ¼ mile to direct water to flow/drain to Pigeon Creek with installation of a tube (NRD) into the drainage ditch. Also, 200th Street acts as a dam and could be drained to Pigeon Creek using a tube. He stated that water is being pumped 24/7 into the ditches along Hwy 35 and that water needs to flow somewhere (Pigeon Creek).

Jeanette Moes, H Avenue, Homer, spoke regarding water in basement, ditches and house yard due to lack of drainage. Commissioner Gill would like to ask the NRD to make a presentation to the Board.

Pat Dorcey, North Bluff Road, Hubbard, clarified that pumps on farm ground near Hwy 35 are on timers and not running/pumping 24/7 and some of the water is from heavy rainfall.

Chair Hohenstein opened the public hearing at 2:15 p.m. for the purpose of hearing public comment regarding the vacationing or abandoning of the following road: 250th Street minimum maintenance portion from S Avenue to Highway 35 approximately 3526.5' in S14 & 23, T27N, R6E, Dakota County, Nebraska.

Pat Dorcey testified in favor of closing 250th Street portion for several reasons: (1) the intersection at S Avenue is unsafe, (2) the road is abused by 4x4 vehicles and (3) trash is dumped. No other comments were given. Chair Hohenstein closed the hearing at 2:17 p.m.

Rogelio (Roger) Hernandez, Sunset Drive, South Sioux City, requested help with the draining of water with a tube under Elgin Drive and direct water south to sandy ground (Milt Peters addition). Fred Kellogg, Highway Superintendent, thought the drainage to the south was uphill. Mr. Hernandez stated he needed another 6" culvert. Mr. Kellogg and Commissioner Albenesius will meet with Mr. Hernandez to try and solve the problem.

Zach Anderson, Ireton Avenue, Homer, was not in attendance. Chair Hohenstein stated he looked at the site and noted the plugged culvert at the end of driveway. Chair Hohenstein said he talked with a contractor who bored a 12" hole to clean out 30" cement culvert near 142nd Street.

Chair Hohenstein moved, seconded by Commissioner Gill, to rescind the March 25, 2019, motion accepting all bids which would allow the Road Department to obtain the material that best fits the project at that given time. ROLL CALL VOTE: Hohenstein- yes, Gomez- yes, Rohde- absent, Albenesius- yes, Gill- yes. UNANIMOUS MOTION CARRIED.

Fred Kellogg, Highway Superintendent, presented the Road Report for March 24 to April 6, 2019. Road maintenance-274.5 hours; culvert project (Inwood)- 19.5 hours; gravel hauling- 198 hours; tons of gravel hauled- 3516.72; sign repair/barricading- 19 hours; road concerns for grading, gravel, pot holes (Thomkins Addition) and culverts (Ireton). Mr. Kellogg stated Lux Brothers, Inc. was the only contractor to bid the Hoag Bridge approaches project (\$31,320). The contractor for the Hoag Bridge plans to pour the deck for the bridge within the next 2 weeks. The High Bridge in Jackson and the South Bluff Bridge, Jackson, are being looked at by contractor. If repairs are made to 265th Bridge approaches and deck, it can be opened.
