Chair Hohenstein explained the County is required to have a Weed Superintendent and the difficulty in filling this position. In discussions with the Road Department Foreman, Lance Jacobsen, and Highway Superintendent, Jolene Gubbels, there is a need for a designated Road Sign position. Chair Hohenstein asked for discussion regarding the creation of a Road Sign/Weed Superintendent position. This person would need to have a CDL and an applicator license (6 months to obtain). This person would also help with road department jobs when needed. Commissioner Love asked who is currently doing signs. Ms. Gubbels advised that the person in the shop works on signs, but they are way behind in the signs area. Commissioner Love moved, seconded by Commissioner Hohenstein to approve the new position of Road Sign/Weed Superintendent within the Road Department. ROLL CALL VOTE: Van Berkum-Yes, Launsby-Yes, Hohenstein-Yes, Love-Yes, Giese-Absent. UNANIMOUS MOTION CARRIED.

Chair Hohenstein explained that in the Employee Handbook it states the Board shall determine by random selection a predesignate list of 15 people to serve on the Grievance Board. Each Commissioner was asked to obtain 3 people who would be willing to serve on this Board and they were given to Board Secretary, Cherie Conley. A Resolution approving the list will be approved at the next meeting.

Jolene Gubbels, Highway Superintendent, presented the Road Report for February 18 to March 2, 2024. Total Road Maintenance – 262.5 hours, Tree/Debris removal – 21 hours, culverts/road projects – 7 hours (180th St), gravel hauling – 98 hours, 41.14 tons hauled, sign repair – 14 hours. Road concern Likuwanta Drive.

Theresa Grove, Health Department Director, presented a Quarterly Report – Immunization Clinic continues to offer Covid vaccine on Wednesdays. Appointments down to 3-5 people per week. Continue to offer Thursday night clinic every other week and last quarter gave roughly 266 vaccines to children. There are currently 15 grants they are working with and recently received a new one for \$25,000 for Diabetes Prevention. Hired a new Emergency Response Coordinator – Chloe Coover.

Chair Hohenstein advised that So Sioux City Grant Writer, Pat Somsky, has agreed to help the County with finding, applying and maintaining grants. She will be contracted on a grant by grant basis. If anyone has any needs they are encouraged to reach out to Ms. Somsky with the details and she will do some grant research.

Commissioner Love moved, seconded by Commissioner Hohenstein to approve the quote from Albireo Energy submitted by Sheriff Kleinberg to finish the installation of the Smoke System with the HVAC system as required by code and jail standards to be paid for using ARPA Funds. ROLL CALL VOTE: Launsby-Yes, Hohenstein-Yes, Love-Yes, Van Berkum-Yes, Giese-Absent. UNANIMOUS MOTION CARRIED.

There were no Committee Reports. Mail and/or Emergency Business-the 2023 Annual Nebraska Loess Hills report was shared.
