Brian Pearson, SIMPCO Facility Director/Transit Director, appeared before the Board and informed that the SRTS busing services in Dakota County has been increasing and the trend looks like approximately 1500 rides will be given in the next year. More rural residents are starting to use the services. Commissioner Hohenstein moved, seconded by Commissioner Launsby to approve funding the Siouxland Regional Transit System (SRTS) busing in the amount of \$15,000 to assist with the expense of 1500 rides per year in rural Dakota County effective July 1, 2024 to June 30, 2025 and is to renew in writing annually. Mr. Kehrt stated he would recommend the low bid to Gill Construction and the completion date is June 15, 2024. Commissioner Love moved, seconded by Commissioner Van Berkum to approve and award the bid to Gill Construction for \$78,605.54. Al Roys, Envirotech Services, presented a slide show and information regarding the soil stabilization process for M Avenue going to Danish Alps/Kramper Lake – Hubbard called BaseBind3X. Continued discussion with the Road Department regarding this process to determine the road width is accurate and obtain estimates from contractors to work this substance into the road.

Jolene Gubbels, Highway Superintendent, presented the Road Report for March 2, 2024 to March 16, 2024.
