Board Member Love moved, seconded by Board Member Giese, to approve the minutes of the August 9, 2021, meeting. ROLL CALL VOTE: Gill- yes, Love- yes, Giese- yes, Albenesius- yes, Launsby- yes. UNANIMOUS MOTION CARRIED.

A hearing was held for the Board to consider all information regarding the application for Exemption from Motor Vehicle Taxes by Glad Tidings Lighthouse, South Sioux City, for their 2018 Chevrolet used for trips, church activities and ministry. Board Member Love moved, seconded by Board Member Giese, to accept the recommendation of approval from the Treasurer and approve the exemption of motor vehicle taxes for Glad Tidings Lighthouse's 2018 Chevrolet used for church activities and ministry. ROLL CALL VOTE: Love- yes, Giese- yes, Albenesius- yes, Launsby- yes, Gill- yes. UNANIMOUS MOTION CARRIED.

Christy Abts, Assessor, updated the Board regarding the recommendation from the Nebraska Associate of County Officials (NACO) regarding the tax-exempt status of Pender Community Hospital clinic located on parcel #220001448 in Dakota County. NACO felt there was no doubt that the Pender Community Hospital District is a subdivision of the State and their exemption status would therefore be governed by a different set of statues. Also, if the County Assessor has determined it is not tax exempt, a notice of taxable status must be sent before March 1st and the notice was not sent. Board Member Love moved, seconded by Board Member Giese, to approve the clinic owned by the Pender Community Hospital District (parcel #22001448) to be tax exempt. ROLL CALL VOTE: Giese- yes, Albenesius- yes, Launsby- yes, Gill- yes, Love- yes. UNANIMOUS MOTION CARRIED.

A hearing was held for the Siouxland Community Health Center regarding their exemption application to withhold taxes for real or tangible personal property on parcel #220141894. Christy Abts, Assessor, stated Siouxland Community Health Center did not own the property on January 1, 2021, and the application was filed after the deadline. The Assessor's Office will send them an application in December to file for 2022. Board Member Giese moved, seconded by Board Member Gill, to accept the Assessor's recommendation (property not owned on 1/1/21 and statutorily late filing) to deny the request for tax exemption for Siouxland Community Health Center (parcel #220141894). ROLL CALL VOTE: Albenesius- yes, Launsby- yes, Gill- yes, Love- yes, Giese- yes. UNANIMOUS MOTION CARRIED.

Board Member Love moved, seconded by Board Member Gill, to convene in closed session to discuss pending litigation in TERC Case #20E-0072 Boys & Girls Home v. Dakota County. ROLL CALL VOTE: Launsby- yes, Gill- yes, Love- yes, Giese- yes, Albenesius- yes. UNANIMOUS MOTION CARRIED at 4:30 p.m. Chair Launsby restated the purpose of the closed session.

Board Member Love moved, seconded by Board Member Albenesius, to reconvene in open session. ROLL CALL VOTE: Gill- yes, Love- yes, Giese- yes, Albenesius- yes, Launsby- yes. UNANIMOUS MOTION CARRIED at 4:38 p.m.

Board Member Gill moved, seconded by Board Member Giese, to approve having the County Attorney prepare a Confession of Judgement for Boys & Girls Home TERC (Tax Equalization Review Commission) Case #20E-0072. ROLL CALL VOTE: Love- yes, Giese- yes, Albenesius- yes, Launsby- yes, Gill- yes. UNANIMOUS MOTION CARRIED.

Discussion was had regarding inviting the schools to attend County Board of Equalization protest hearings since most people protest their value because the increase in value will most likely increase their tax payment. The County Clerk will organize the protests by school district.
